Tree 1. Is in the rear garden of 161 Caxton End and has compromised the safety of the overhead cables by causing the pole to lean at a dangerous angle. A new pole will be need once this tree is felled. This tree is in a Conservation Area. Tree2. Is also in the rear garden of 161. It is not in a Conservation area but may be subject of a TPO as it is beside public footpath 30. It needs to be felled to allow for a new Telegraph Pole to be inserted to carry new overhead power cable to 161a. New cables are required as the existing cable run too close to 161 and are too low. This is both dangerous and prevents redevelopment of 161. Trees 3 and 4.
