1. How many citizen records did your authority collect in Q1 2020 (January, February and March)?

Number of digitised citizen records: Jan 2020 = 478 Feb 2020 = 389 March = 373

Number of paper-based citizen records: Jan 2020 = 39 Feb 2020 = 34 March = 22

2. What approximate percentage of this content (your citizen records) is shared with third-party organisations? • 100% with those legally permitted organisations such as political parties, credit agencies and jury service. Approx. 30% (the open register) with anyone who wishes to purchase it. The option to opt out of the open register is available to all.
3. Is your local authority adopting a content services platform to collaborate with third-party organisations? • No, we do not plan to do this for electoral services.
4. Is your local authority adopting a content services platform to enable staff to access files remotely and collaborate more easily? • No, we do not plan to do this for electoral services as we can easily access our system at work and remotely already.
5. Does your local authority currently offer your local citizens online access to their own records? • No - they cannot access their own digital records online for electoral services.
