South Cambridgeshire District Council (SCDC) Publication Scheme: Guide to Information

1.1 Model Publication Scheme

The Freedom of Information Act requires all public authorities, which includes South Cambridgeshire District Council, to adopt and maintain a Publication Scheme.

As of January 2009, South Cambridgeshire District Council has adopted the Information Commissioner's new **Model Publication Scheme**, which represents a commitment to publish information within seven broad classes of information.

These are:

- Who we are and what we do
- What we spend and how we spend it
- What our priorities are and how we are doing
- How we make decisions
- Our policies and procedures
- Lists and registers
- The services we offer

The classes of information will not generally include:

- Information, which is generally prevented by law or exempt under the FOIA, or is otherwise considered to be protected from disclosure;
- Information held in draft;
- Information that is no longer readily available as it is contained in files that have been placed in archive storage, or is difficult to access for similar reasons.

1.2 How to access Published Information

The purpose of this guide is to provide details of the kinds of information that the Council routinely publishes. The majority of this information is available on our website.

However, if you are unable to obtain the information from our website please contact the relevant Service via our Customer Contact Centre on 0345 450 500 to make the request, or to make an appointment to view the information at the Council's Offices.

All information will be provided in the language in which it is held or in such other language that is legally required. Where an authority is legally required to translate any information, it will do so.

Obligations under disability and discrimination legislation and any other legislation to provide information in other forms and formats will be adhered to when providing information in accordance with this Scheme.

Requests for information can be made in person at the **Council's offices**, by post, email or via our <u>website</u>. However, if you have any questions about how to access this information, please telephone or email the relevant Service.

1.3 How to access other information

Access to unpublished information can be made by making a request in writing under the Freedom of Information Act 2000 (FOIA) or the Environmental Information Regulations. A request will be handled in accordance with the Council's **FOIA Policy and Procedure**.

However, disclosure of certain information may be prohibited because it relates to an individual and is protected by the Data Protection Act or is subject to exemptions under the FOIA. Further information is available in the Council's FOIA Policy and Procedure and official guidance published by the Information Commissioner's Office.

1.4 Charges which may be made for information published under this scheme

The purpose of the publication scheme is to make information available at minimum cost. Charges made by the Council for routinely published material will be justified and transparent and kept to a minimum.

Information which is published and accessed on our website will be provided free of charge. Charges may be made for information subject to a charging regime specified by Parliament. Charges may be made for actual disbursements incurred such as:

- Photocopying
- Postage and packaging or
- The costs directly incurred as a result of viewing information.

Charges may also be made for information provided under this scheme where they are legally authorised, justified and in accordance with a published schedule or schedules of fees which is readily available to the public.

If a charge is to be made, confirmation of the payment due will be given before the information is provided. Payment may be requested prior to provision of the information.

1.7 Copyright

Copyright is asserted by the Council in respect of all of the information provided by the Council in the public domain. The information, and any document or record in which it appears, must not be substantially reproduced except with the permission, in writing, of the Council, although minor extracts are reproducible without separate permission provided the source of the extract is clearly stated and the Council's interest is acknowledged. This constraint is not intended to restrict any lawful request for information.

The supply of documents to a member of the public does not grant the right to re-use this information in a way that would infringe any copyright on those documents.

Provision of information under this publication scheme or under access legislation does not give the recipient an automatic right to re-use it, for example, to publish it, or adapt it in any way. Most information supplied in response to an access request will be protected by copyright and permission to re-use it, will be required. The Re-use of Public Sector Information Regulations provides a framework for obtaining this permission.
