There are a number of tools that our officers use to support the delivery of climate related planning policy including the detailed guidance contained in our Greater Cambridge Sustainable Design and Construction SPD and tools developed by other external bodies such as the Good Homes Alliance Overheating Toolkit. Regarding the development of new policy, working with consultants we have developed a carbon assessment tool to help assess the carbon implications of our spatial strategy.

Our principal sustainability consultant has undertaken climate literacy training and also provides training on the implementation of climate related policies to our planning officers.
