A. Status and scope of the policy being assessed

A1. What are main aims, objectives, purpose and intended outcomes of the Policy?

Cambridge City Council and South Cambridgeshire District Council (referred to as the Councils in this consultation) are working together to create a joint Local Plan for the two areas – which we are referring to as Greater Cambridge. This will ensure that there is a consistent approach to planning, and the same planning policies, where appropriate, across both areas.

Both Councils adopted their current Local Plans in 2018. Both Plans include a commitment to an early review, in particular to update the assessment of housing needs, to review the progress of delivering planned developments including new settlements, and to consider the needs of caravan dwellers and government changes to the approach to planning for Gypsies and Travellers.

A six-week public consultation period is taking place from 9am on Monday 13 January 2020 to 5pm on Monday 24 February 2020.

This is the first stage towards preparing the Greater Cambridge Local Plan - a new joint Local Plan for Cambridge and South Cambridgeshire. The 'first conversation' explores the 'big themes' that will influence how homes, jobs and infrastructure (such as transport links, schools and healthcare) are planned. It is not the plan itself but seeks views on the issues that the plan should address before the plan is drafted and further consultation takes place.

A2. What is the status of this Policy? (New, existing or under review)

Once adopted, the Greater Cambridge Local Plan will supersede the South Cambridgeshire Local plan 2018 and the Cambridge Local Plan 2018.

The Issues and Options report is an early and informal stage in the plan preparation process.

A3. What is the timescale and decision-making route for approval of the Policy?

We are currently at an early stage in the development of the new Local Plan, which will be prepared in stages over about four years. An outline timetable that was included in the adopted [Greater Cambridge Local Development Scheme 2018 \(as updated 2019\)](#)¹. The Local Timetable in the Adopted Local Development Scheme.

- Early Plan preparation Work Summer 2019.
- Consultation on Issues and Options – This consultation.
- Consultation on draft Local Plan Autumn 2020
- Proposed Submission publication Autumn 2021
- Submission to Secretary of State Summer 2022
- Examination period Winter 2022

- Local Plan adoption Summer 2023
- Review and monitoring 2023 and ongoing

At each stage we will check that the process is moving forward positively towards a new Local Plan and, if necessary, we will adjust the timetable.

The plan will go through several consultation stages prior to its submission to the secretary of state for adoption. The local plan will be considered by members through each stage of its preparation. The decision to adopt will rest with full Council.

The EQIA will be revisited at the next formal consultation stage of plan making, anticipated to be the draft plan / preferred options stage.

A4. Is this policy associated with the Council's strategic Aims, Approaches and Actions (The Three 'A's)? If so, please state the relevance and association to The Three 'A's.

The Greater Cambridge Local Plan Issues & Options consultation draft text seeks to address and raises questions about all of the below priority areas, alongside Cambridge City Council's corporate priorities.

- Growing local businesses and economies
- Housing that is truly affordable for everyone to live in
- Being green to our core

A modern and caring Council

The approach to engagement and participation in the Local Plan supports the Council's priority of being a modern and caring Council. As noted above, the aim is to put community engagement at the heart of the Local Plan development process,

reaching all parts of the community within Greater Cambridge. Linked to this, a web first approach is intended to be used for the Issues & Options consultation, with the wording and format of the document intended to be accessible to all.

A5. Who are the intended beneficiaries / stakeholders of the policy or function? How many people are affected and from what sections of the community?

Consultation and community engagement will be undertaken in accordance with the Statement of Community Involvement. There is also a Statement of Consultation to address the measures being taken for consultation on the Local Plan. The views expressed by individuals, communities, businesses, academic institutions and stakeholders during this consultation will help us develop and refine the options for further testing and then identify the preferred approach to the themes and areas for growth, and the draft plan itself.

Residents, workers, and visitors to Greater Cambridge are all stakeholders in the plan.

A6. Are external partners involved in delivering this policy? If so, what are their roles, and level of involvement / influence?

Yes.

A Local Plan is a legal document that the Councils are required to prepare, which sets out the future land use and planning policies for the area over a set time frame. It identifies the need for new homes and jobs, and the services and infrastructure to support them, and guides where this growth should happen. A range of stakeholders are involved not only in helping the develop the plan, but also to implement it.

In addition, Greater Cambridge Shared Planning Service, as the Local Planning Authorities, have been working with Greater Cambridge Partnership, Cambridgeshire & Peterborough Combined Authority and a wide range of delivery partners as the consultation has been prepared.

B. Evidence, data and consultation

B1. What monitoring or other information do you have about relevant target groups, which will show the impact of the Policy?

A Sustainability Appraisal Report of the Issues and Options Report has been prepared by independent consultants LUC (Land Use Consultants) on behalf of South Cambridgeshire District Council and Cambridge City Council (the Councils) as part of the Sustainability Appraisal (SA) (incorporating Strategic Environmental Assessment (SEA), Health Impact Assessment (HIA) and Equalities Impact Assessment (EqIA) of their Local Plan.

Throughout the plan making process the SA will consider whether the Local Plan is likely to disproportionately affect any groups with particular 'protected characteristics' under the Equality Act, as well as whether the Local Plan may disproportionately affect any other groups, such as different socio-economic groups.

A SA Scoping Report has been prepared and is being consulted on alongside the Issues and Options Report. This reviews relevant plans and strategies and identifies the baseline against which to consider impacts of the plan. Each option as the plan is developed will be tested against a set of sustainability objectives

The Councils' adopted Local Plans are subject to an Annual Monitoring Report, published each year in January, and made available on the Councils' websites. Later in the plan making process, a set of monitoring indicators will be developed specifically for the plan.

B2. Have you compared the data you have with the equality profile of the local population? What does it show?

Equalities issues have been included in the data collated in the Sustainability Appraisal Scoping Report. In particular see chapter 3 on Population, Health and Wellbeing.

B3. Have you identified any improvements or other changes that could be made from monitoring the data?

The data, along with a series of stakeholder workshops held in summer 2019, has helped to shape the issues and options consultation. One of the four key themes of the consultation is: Wellbeing and social inclusion – how the plan can help spread the benefits of growth, helping to create healthy and inclusive communities.

Improvements to the consultation methods proposed have also been identified to reach hard to reach groups, including young people.

A range of methods of notification will be used to inform the public about the consultation including:

- Public notice in the Cambridge Independent
- Joint Cambridge City Council and South Cambridgeshire District Council news releases
- Articles in Cambridge Matters & South Cambridgeshire Magazine, and wider local media engagement
- social media and video
- Posters (available to download, paper copies available on request, distributed to venues such as libraries)
- Postcard handouts at pop up events

Roadshow: The Councils will take a pop-up exhibition to community hubs around the area such as shopping centres, schools, community centres and other places. These events will be informal and offer the opportunity for the public to find out about the Local Plan, and to discuss the issues and options with officers and to provide quick feedback via postcards. The times and locations of the drop-in events have been chosen to maximise our outreach to diverse communities.

We will also be holding a 'Big Debate' on the evening of 18 February, where we are inviting local groups to share their ideas about what should be in the Local Plan, in a fun, provocative and lively public event.

A series of stakeholder workshops were held in summer / autumn 2019. A series of stakeholder workshops were held in summer / autumn 2019. One of these included internal council stakeholders.

Chapter 4 of this document provides a summary of the discussions at the workshops, with further detailed provided in a number of appendices to the document.

The Issues and Options Report has been tested through an initial Sustainability Appraisal. The Sustainability Appraisal accompanying considers the broad themes being considered, and their potential impacts.

Given the broad nature of this consultation, the SA Report contains a high-level commentary on the sustainability considerations for the Local Plan, in relation to the themes discussed in the Issues and Options document. SA of the more detailed options for the Local Plan will be undertaken as they are developed.

Two big themes relevant to equality for the development of the Local Plan for consultees to consider are:

- Wellbeing and social inclusion – how the plan can help spread the benefits of growth, helping to create healthy and inclusive communities.
- Great places – how the plan can protect what is already great about the area, and design new developments to create special places and spaces.

The Issues and Options Report also seeks views on whether future growth should be focused in the Greater Cambridge Area. Options have been identified which cover the broad alternatives available. The assessments below consider both the principle of focusing growth at each particular option and, where appropriate the implication of possible locations coming forward under that option. In order to be precautionary, any potential effects that could arise at particular locations where development could come forward under an option have influenced the overall likely effect recorded in the appraisal.

With regard to SA Objective 3: 'To encourage social inclusion, strengthen community cohesion, and advance equality between those who share a protected characteristic (Equality Act 2010) and those who do not', the following assessment was made in the appraisal.

Option 1 Densification. – would result in an increase in the density of development in Cambridge, and therefore an increase in population. Residents would have good access to services and facilities, which would improve equalities by benefitting those with protected characteristics (Equality Act 2010), particularly those who are less mobile, such as the elderly or disabled, and could strengthen inclusivity and community cohesion. Therefore, Option 1 is expected to have a minor positive effect against this objective.

Option 2 Edge of Cambridge – Outside the Green Belt. is likely to be of sufficient scale to create a new cohesive community with its own identity, as well as deliver a range of homes, jobs, services and facilities to meet different needs. It is also well located to the existing urban area, and therefore creates opportunities to be integrated with, and also serve, existing communities, although there could be disruption whilst it is developed. It is therefore considered likely to have significant positive effects against this objective, albeit with uncertainty.

Options 3 Edge of Cambridge – Green Belt and 4 Dispersal – new settlements. could see the creation of new infrastructure, such as schools, local centres and green spaces, which could act as a focal point of community life. With regard to Option 3, the range of services and facilities provided at particular development locations will likely depend on the size of the extension. Although an urban extension can achieve its own sense of place, integration with the existing urban areas and communities will be important if negative effects on existing communities are to be avoided.

With respect to new settlements under Option 4, it can take many years for their delivery and to achieve a scale and critical mass that generate a strong sense of community. They involve building new communities from scratch which can prove challenging and cohesiveness can depend upon both the quality and design of development, and its delivery to schedule. Overall, both options are likely to have a mixed significant positive effect with uncertain minor negative effects.

Option 5 Dispersal – villages would result in an increase in development at villages across Greater Cambridge, which could help support the vitality and viability of these villages and help to support community cohesion. However, more dispersed development could place increasing pressure on existing services and facilities within these villages if sufficient investment to maintain and improve them is not forthcoming. Therefore, Option 5 is likely to have a mixed minor positive and minor negative effect against this objective.

An increase in development along key public transport corridors with good access to Cambridge as set out in Option 6 Public transport corridors may benefit those who are less mobile, with a positive effect on inclusivity. However, it may be more challenging for development along public transport corridors to achieve a coherent sense of community and place, depending upon where particular developments come forward under this option and their relationship to existing communities. Therefore, Option 6 is considered to have mixed minor positive and minor negative effects.
