Having looked at the letter from Bidwell's and Jonathan's original response I consider that the main issues highlighted in Jonathan's comments are still of concern and his conclusion remains the same. Whilst the details of why Option 5 has not been pursued are noted it does not change the fact that the main building is a NDHA for the reasons outlined by Jonathan and the proposals will result in total loss of that heritage asset. Paragraph 203 of the NPPF states that a balanced judgement will be required having regard to the scale of any harm or loss and the significance of the heritage asset. The loss of a NDHA can be mitigated by the quality of what replaces it and Jonathan's comments on the design of the new building are still valid as are his comments relating to the site layout and loss of the "Girton Gap".


