Appendix A Traffic Model Summarised Results

1.1.3 This Appendix presents the results of the traffic modelling exercise. They present the worst performing peak hour at each location, and the worst performing lane or connecting link. The Delays are shown here in s/pcu, which is the delay experienced by a car caused by queuing. The Queues are measured in pcu, which is a 'passenger car unit', referred to as a length of 5.75m. A HGV by comparison would be represented by 2 pcu. 'Circ' refers to the circulatory carriageway of a roundabout.
