## Cambridge Local Plan and South Cambridgeshire Local Plan: Proposed Modifications

With reference to your letters regarding your preliminary conclusions to our respective Local Plans<sup>1</sup>, and the Councils' related correspondence<sup>2</sup>, the further work undertaken by the Councils to address your concerns, including accompanying proposed modifications, has now been completed.

As you are aware, further work was undertaken in relation to Objectively Assessed Need for New Housing, Overall Development Strategy and Conformity with National Planning Policy between July to October 2015. Public consultation on resultant proposed modifications arising from this work took place between the 2 December 2015 and 25 January 2016. Following consultation the Councils have considered all representations received and have assessed, in light of the issues raised, whether the proposed modifications should be submitted as consulted on, with amendments, or not at all. Any changes to the proposed modifications considered necessary in response to issues raised during the consultation have also been identified.

A schedule of proposed modifications for each Local Plan (<u>RD/MC/140</u> and <u>RD/MC/150</u>) has been prepared along with a joint Report on Consultation (<u>RD/MC/120</u>). The Report on Consultation outlines for each issue the further work undertaken, the proposed modification consulted on, the number of representations received to each proposed modification, a summary of the key issues raised, the Councils' assessment and the way forward for each Proposed Modification consulted on.

All evidence base documents have been added to the reference document library and for completeness a list has been provided as an attachment to this letter. Hard copies of all documents have been provided as well as being made available electronically via the reference document library.

Please note the separate letter (<u>RD/GEN/280</u>) from South Cambridgeshire District Council in respect of the provisional Modification to the South Cambridgeshire Local Plan to allocate land south of the Cambridge Biomedical Campus (CBC).

As you know, the Councils are in the process of reviewing the Gypsy and Traveller Accommodation Needs Assessment and will provide an update in due course. The Councils are also progressing work in relation to accessibility standards, and South Cambridgeshire District Council are also undertaking work in relation to residential space standards.

As previously outlined, the Councils are committed to putting plans in place to deliver growth in the Greater Cambridge area as soon as possible and have completed the further work to timetable in order to move matters forward. We hope that the further work undertaken means that the Examinations can be reopened and move swiftly forward. We note from the latest Hearings Programme that you anticipate hearing sessions starting again at beginning of June 2016 and that sessions will start with Joint Strategic Matters and then move onto City only matters, before then moving to hearings relating to South Cambridgeshire only. In order to help facilitate this, the Councils have made appropriate accommodation available.
