A. POLICY, PRACTICE, FUNCTION OR PROJECT TO BE ASSESSED

A1. Please describe what are the main aims, objectives, purpose and intended outcomes of the policy or function?

The DPD is meeting the planning requirements set out at all levels of government: the DPD builds on national policy in Planning Policy Statements (PPS), particularly PPS 1: Delivering Sustainable Development, which promotes sustainable, well-designed development. It is also consistent with the Regional Spatial Strategy, Structure Plan "saved" policies and the Council's Core Strategy DPD, which sets out the overarching strategy for development within the district.

The Local Development Framework (LDF) contains a number of site specific policies, including allocations for housing and employment development, and safeguarding land for transport infrastructure. These are detailed in the Site Specific Policies Development Plan Document (DPD) and should ensure the delivery of the vision and objectives of the Core Strategy DPD.

A2. Is this policy or function associated with any other Council policy or priority?

The Site Specific Policies DPD is one of a suite of documents that make up the Council's LDF. It is closely associated with the Council's Sustainable Communities Strategy 2008-11.

It is also linked with Council Aim C: We are committed to making South Cambridgeshire a place in which residents can feel proud to live, and Council Aim E. We are Committed to Providing a Voice for Rural Life, Approach i. Protecting existing communities, villages and the countryside.

A3. Who are the intended beneficiaries/stakeholders of the policy or function? How many people are affected and from what sections of the community?

The delivery of development outlined in the DPD will assist the local economy as well as new and existing residents within the district. The DPD will deliver a mixture of employment, residential, recreational and other community uses with the intention of creating balanced communities. Although the DPD covers the whole district, allocations for development are only in certain locations; mostly in the more sustainable larger settlements or the edge of Cambridge. Delivery of the allocations will involve a number of stakeholders to ensure the provision of all necessary infrastructure to serve the development.

A4. Is the policy/function corporate and far-reaching?

Yes. The DPD covers the whole district and has significant implications in terms of future development within the district.

Meets Council aims (see A2 above).

A5. Are you expecting to make any significant change to the policy or service in the near future? If so, please give details.

No changes are anticipated. Adoption of the DPD is the final stage in a lengthy process involving several rounds of public participation (see B4 below).

A6. Is this a new or existing policy or function?

The LDF is a new policy document under a new system of plan-making that replaces the old Local Plan 2004. The LDF contains many similar policies to those in Local Plan 2004. Adoption of the Site Specific Policies DPD means that the Local Plan 2004 has largely been replaced.

These are new monitoring indicators and will be monitored during 2010-11 and reported in the Annual Monitoring Report for that period, and subsequent years. Existing indicators in the Annual Monitoring Report provide information on similar subject areas and can be reported in 2009-10.

B3. Have you identified any improvements or other changes that could be made from monitoring the data?

The DPD sets out the policy framework for future development, and addresses the provision of a safe and accessible environment for all people, with development that meets the needs of everyone, for example in terms of community facilities and housing mix. The DPD policies are used in the development of Masterplans for larger development sites and in the determination of planning applications. Therefore it may be possible to monitor how well the policies are be implemented in the delivery of the developments allocated in the DPD through the planning application process (see Action Plan).

B4. Have you consulted or involved external stakeholders about the policy or function? If so, what were their views?

The DPD, and associate Sustainability Appraisal, have been produced working with key stakeholders and subject to several rounds of public consultation during their preparation.

The Council carried out an initial consultation (for four weeks) with statutory bodies on all the matters which would be covered by the DPD, as required under the system of plan making, to ensure that it was aware, at an early stage of any programmes and plans that would affect the LDF. The responses received were taken into account in preparing the Preferred Options Report.

A six-week public participation on Preferred Options gave consultees, stakeholders and the public the opportunity to comment on how the local planning authority should approach the preparation of the DPD. The Preferred Options Report focused on key issues for the DPD and issues where there were choices to be made on the policy direction. The scope for strategic choices in particular was limited in by the specificity of policies in force at that time in the Regional Planning Guidance (RPG6) and the Cambridgeshire Structure Plan 2003, now carried forward in the East of England Plan (RSS14) and the "saved" policies of the Structure Plan.

An additional round of public participation on the draft DPD (Pre-Submission) was carried out for six weeks. The responses received informed the Submission draft plan. This was submitted to the Secretary of State in January 2006 (alongside five other DPDs). A further six-week period of public consultation was undertaken. Some alternative sites were put forward during the consultation and the Council advertised these (known as objection sites).

Independent planning Inspectors were appointed to examine the 'soundness' of the DPD, and took into consideration all the representations received during the Submission consultation and subsequent objection sites consultations. During the examination the Inspectors concluded there were not sufficient allocations to meet the housing requirements contained in the adopted Core Strategy DPD. The Council undertook additional work, assessing potential sites, before consulting on the proposed additional sites to make up the shortfall, which informed the Council's final recommended sites to the Inspectors to make up the shortfall. The Inspectors subsequently reported their conclusions, which are binding on the Council, and the Council can adopt the DPD.

Yes, internal consultation was undertaken during the preparation of the DPD, including with Development Control, Major Developments, New Communities, Conservation, Housing, Environmental Health, which has ensured the preparation of a sound plan that takes account of all relevant interests.

These policies are used in the development of Masterplans for larger development sites and in the determination of planning applications. However, the delivery of the LDF is outside the remit of this Equality Impact Assessment. To ensure the delivery of development is meeting policy aims, it would be possible to screen the planning application process to assess how well the DPD policies are being implemented in the delivery of the developments in terms of their impact on target groups (see Action Plan).
