A. POLICY, PRACTICE, FUNCTION OR PROJECT TO BE ASSESSED

A1. Please describe what are the main aims, objectives, purpose and intended outcomes of the policy or function?

The purpose of the SPD is to expand on Policies SF/10 and SF/11 in the adopted Development Control Polices DPD, adopted in July 2007.

The SPD details the requirement for onsite provision of public open space and play facilities within new developments and provides a summary of the standard required by the District Council for the different types of open space as defined in the DPD. The SPD includes a calculation for offsite commuted sums to be paid to facilitate the provision of additional or improvements to existing open space, sports pitches and play areas.

The overarching objective of the SPD is to assist achievement of the Development Control Policies DPD Objective SF/h: "to ensure the proper provision and maintenance of open space and sports facilities consistent with levels of planned residential development and identified open space standards."

Specific objectives of this document are to:

- Assist applicants gain planning permission quickly by informing them of what contributions are required and why, as well as how
 provision and payments should be made;
- Ensure that Parish Councils and / or the local community are involved in decisions that affect public open space provisions within new developments;
- Ensure that new facilities provided are appropriately designed to maximise amenity;
- Ensure that facilities provided are properly managed and maintained for maximum community benefit.

A2. Is this policy or function associated with any other Council policy or priority?

The Open space in new developments SPD supplements the adopted Development Plan Document policies SF/10 and SF/11 in the Development Control Policies DPD: <u>www.scambs.gov.uk/ldf/dcpoliciesdpd</u>.

A3. Who are the intended beneficiaries/stakeholders of the policy or function? How many people are affected and from what sections of the community?

The policy is intended to mitigate the impact of new development by providing areas of onsite public open space, as well as funding improvements to existing recreation infrastructure for the benefit of new residents.

Monies received are secured via legal agreements under section 106 of the Town and Country Planning Act 1990 (section 106 agreements) and are normally paid directly to South Cambridgeshire District Council for onward transmission to Parish Councils who are responsible for the allocation.

The provision of formal and informal open space will directly and indirectly benefit all sectors of the community, whether local residents, businesses or visitors to the area. Open space helps make places which are attractive, healthy and give a good quality of life to deliver social, economic and environmental benefits.

Stakeholders include:

- Current and future residents and Local Members in South Cambridgeshire.
- Parish and Community Councils in South Cambridgeshire.
- Businesses in South Cambridgeshire.
- Visitors to South Cambridgeshire.

A4. Is the policy/function corporate and far-reaching?

Yes, the SPD applies district wide, and links with several Council aims (see A.2 above). Provision of formal and informal open space has the potential to impact on all people, both directly and indirectly.

A5. Are you expecting to make any significant change to the policy or service in the near future? If so, please give details.

The policy may eventually be incorporated in some part in a future Planning Obligations SPD and charging schedule as part of the community infrastructure levy regulations 2010.

A6. Is this a new or existing policy or function?

The SPD adopted in January 2009 supplements and amplifies the adopted Development Plan Document policy that was adopted in July 2007.

B. EVIDENCE/ DATA and CONSULTATION

B1. What monitoring or other information do you have about relevant target groups, which will show the impact of the policy or function?

The open space in new development SPD followed and was supported by a recreation study undertaken in 2005 (<u>www.scambs.gov.uk/Environment/Planning/DistrictPlanning/LocalDevelopmentFramework/Archive/RecreationStudy</u>) that assessed the quantity and quality of all areas of open space within South Cambridgeshire villages. Annex 1 to the assessment identified, for each village, the current sports and children's play provision, a comparison with the recommended playspace standard, current use and demand, and was therefore able to identify where necessary improvements should be prioritised at a local level. A quantative update of this study was carried out in 2010 with a questionnaire to be issued to Parish Councils in 2011 to understand the current qualative situation.

The purpose of the recreation study was to also provide the Council with a 'standard' of necessary open space per person to calculate onsite provision from new residential schemes but to also calculate a cost of providing and maintaining this area if an offsite contribution was sought. The amount of money required from new development does not alter depending on which village the development is located, therefore whilst the needs of each Parish vary considerably monies requested from developers will be based on the generic impact the new residents would bring.

South Cambridgeshire District Council as the local planning authority collects these monies from new development on behalf of Parish Councils, although it forgoes any responsibility in terms of project allocation. Parish Councils are responsible for determining how the money is to be spent in accordance with changing priorities and against any adopted Parish Plan. In South Cambridgeshire there are currently 16 plans (including one refresh) being undertaken and 28 plans completed.

It is common for Parish Council's to have aspirations for increasing the size of recreation areas and improving the standard of children's play.

The County Council Research Group provide a break down of Census information in district and ward level profiles. This includes useful information on Age. The next Census will be undertaken in 2011, however in the interim the Group have also produced estimates of population for 2008.

B2. Have you compared the data you have with the equality profile of the local population? What does it show?

New development has the potential to deliver formal and informal open space and recreational facilities that will impact on all people in some way or form, whether they are local to the area or visiting.

The County Council Research Group provide a break down of Census information in district and ward level profiles for the resident population, however, there is no readily available information on people working in or visiting the district. Therefore, there is no complete profile for all the people who may be affected.

B3. Have you identified any improvements or other changes that could be made from monitoring the data?

The provision of formal and informal open space will directly and indirectly benefit all sectors of the community, whether local residents, businesses or visitors to the area. Open space helps make places which are attractive, healthy and give a good quality of life to deliver social, economic and environmental benefits.

The District Council is keen to ensure its quantative and qualative information is up to date to ensure that the policy is defendable against challenge and remains relevant and reasonable. However as it is only responsible for collecting the monies and is not responsible for allocating monies collected against local projects, it does not undertake any monitoring to assess whether this is being done in the most effective manner, incorporating all groups within the community.

B4. Have you consulted or involved external stakeholders about the policy or function? If so, what were their views? There was an article in the Summer 2008 edition South Cambridgeshire Magazine about the consultation.

The draft SPD was subject to six-weeks public consultation with a range of external stakeholders from 6 June to 18 July 2008. During the consultation the draft SPD was available on the SCDC website <u>www.scambs.gov.uk/ldf/spds</u>. A Statement of Consultation has been produced and details the representations received and subsequently amendments have been incorporated into the final adopted SPD.

A total of 68 representations were received during the consultation period of which 9 were supporting and 59 objecting to the draft SPD. The issues raised include:

- Concern that there are parts of the SPD which appear to be seeking to create new policy rather then providing greater detail on the policies in adopted Development Plan Documents.
- Concern that the full hierarchy of green infrastructure has not been considered in the Draft SPD, with Strategic Open Space not included.
- Suggestion that greater clarity about the application of the Open Space SPD to Area Action Plans should be provided.
- Concern over the insistence on 50% of equipped play space and there being no justification in national policy guidelines.
- Concern that non-residential developments are required to contribute towards outdoor playing space, as there is no such reference in Policy SF/10.
- Concern over the use of Cambourne as the model for occupancy rates and sports participation rates, as Cambourne is considered unrepresentative of overall patterns of supply and demand throughout the District.
- Concern over the period of maintenance contributions, calculations used, and consistency with Circular 05/2005.
- Various concerns over the areas included in list of areas and facilities that do not contribute towards Open Space Standards.

B5. Have you undertaken any consultation with staff to assess their perception of any impacts of the policy or function? If so, what has been learnt from them?

Yes, internal consultation was undertaken during the preparation of the SPD. The Consultation Statement details the comments received: www.scambs.gov.uk/ldf/spds.

B6. Please provide information about any other consultation, research, or involvement undertaken in relation to this impact assessment.

The SPD was published for a six-week public consultation, as detailed in B4 above. A public notice was placed in the Cambridge News at the start of the public consultation. A number of stakeholders were sent a letter and CD-Rom containing each of the public participation documents, supporting documents, and forms for making comments. All documents were available to view and / or download from the Council's website: www.scambs.gov.uk/ldf/spds, and a link was included from the home page. Interactive online versions of documents were also available to enable people to make comments online during the consultation period, as well as Word and PDF versions of a response form that could be completed and emailed / posted to the Council. South Cambs Magazine, which is delivered to every household in the district, also included information on the consultation. Printed copies of the document were also available to view or purchase at the Council's offices.

Young people are a particular focus of the SPD and the types of facility that are to be provided as part of new development are based according to age group and needs. The policy also references the inclusion of buffer zones which are multifunctional in that they provide a sound buffer but also provide a distance from housing to play area thereby improving child safety.

A quarter of Parishes in South Cambridgeshire have adopted Parish Plans that are based on consultation responses issued to everyone living in the village. It is envisaged that a policy raising additional income streams for local communities would result in an increase level of active participation in local governance and therefore improve and create relationships.
