This is a consultation that is taking place to help us to obtain feedback in to assist with the development of the Council's 2026-27 Corporate Action Plan and budget. The consultation seeks to obtain the opinions of those who live and work within South Cambridgeshire on how the Council should seek to progress its 5 Corporate Plan priority areas during the 2026-27 financial year. The consultation will be available (primarily) digitally with the option of hard copies and other languages through our Go Vocal corporate engagement and consultation platform.

Promotion of the survey will be promoted through the Council's established consultation and engagement platform. The Communications Team will promote the survey through Council communications channels such as social media, websites and distribution mailing lists. Where timing allows, the survey will be promoted through service specific communications channels, such as the Business Development team's Business Support Newsletter, the Climate and Environment Service's Zero Carbon Communities Newsletter and the Housing Service's Tenant Newsletter (amongst others). It will also be possible for the survey to be requested in alternative formats and languages, while respondents will also be able to contact the council's Contact Centre for support in completing the survey.

Staff leading and managing the consultation process have had training in delivering effective consultations (delivered by the Consultation Institute). A similar consultation was undertaken in Autumn 2024 to help inform the development of the 2020-25 Corporate Plan. Details: Whilst there has been an SCDC corporate shift to encourage digital customer interactions, and many people value the ability to complete tasks quickly and easily online, studies also show (as detailed below in relation to the Age



Details: Older persons may be less likely to engage with online content, utilise digital services, complete forms digitally or even simply access the internet. Age UK statistics show that 18% of people aged 65+ and over (estimated 2.3 million people) do not use the internet and among people aged 65+ in 2023, 21% are unable to fill in forms online. As such, hard copies of the survey will be available and signposted on the Council's engagement platform, as will support in completing the surveys through the Council's Contact Centre Service. Having said this, responses to recent SCDC consultations, such as the independent surveys carried out by DJS Research in relation to the 4DW, have found that older people tend to be more aware of and likely to respond in relation to local Council affairs. For example, this research found that "awareness of the 4DW trial is higher among those who are older, with only 32% of those under 35 aware, compared to 65% of those aged 35-54, 75% of those aged 55-64 and 81% of those over 65." While it may not be possible to extrapolate findings about one specific subject to all Council affairs, it does provide useful insight that aligns with other anecdotal reports. To mitigate challenges associated with obtaining input from younger people, the Greater Cambridge Shared Planning Service's successful Youth Engagement Service will be contacted to enquire as to whether a session can be run to obtain input from younger people, as was the case in relation to the 2024 Corporate Plan consultation.

Details: Disabled people are less likely to use the internet and therefore would be negatively impacted by a digital only consultation. According to ONS internet users data (2020), of adults over 16, considered as having a disability (as defined by the Equality Act), 81.4% had used the internet in the last 3 months however 14.9% had



never used the internet. This compares with 95.7% of people without a disability used the internet in the last 3 months, with only 3.4% having never used the internet. The engagement platform and survey has been designed to be e-reader friendly and compliant with WCAG 2.2. The survey is also available in different formats and languages including braile and BSL.

Details: At the time of the 2021 Census, in South Cambridgeshire 3.84% of residences did not have anyone who spoke English as a main language. 1.4% of residences had at least one child (3-15years) who had English as their main language. 3.79% of residences had at least one adult who spoke English as a main language (Census 2021). This data suggests that there is 9.03% of residences in South Cambridgeshire where there may be limited spoken English. Therefore it is important that an option is available to ensure that this survey is made available in alternative languages. This is available through built in translation functionality within the Go Vocal platform (Ukrainian and Polish languages can be provided with a simple click of a toggle button on the platform, indicated visually with a flag for these nations), as well as through the Council's Translation contract with AA Global.
